


Overview

The **HKEX Tech 100 Index** (the “**HKEX Tech 100**”) is designed to measure the performance of 100 of the largest Hong Kong-listed companies with high exposure to key tech themes, that are eligible for Southbound Stock Connect, addressing growing market demand for diversified exposure to the technology sector.
