### **Overview**

The **HKEX Ether Index Series** is designed to measure the price performance of Ether, providing real-time and daily reference prices in the Asian time zone. The real-time reference index, **HKEX Ether Reference Index**, is a 24-hour volume weighted reference spot price using prices aggregated from the major virtual asset exchanges. The daily reference rate, **HKEX Ether Reference Rate**, is designed for the settlement of financial products. The daily reference rate is calculated every day within the 1-hour window from 3-4pm HKT, designed specifically for use by Asian investors and issuers. The index series is calculated every day including business holiday.
