# Attestation Report on Pre-issuance of China Construction Bank Singapore Branch's

### 2021 Transition Bond

## To China Construction Bank Singapore Branch

We have been engaged by China Construction Bank Singapore Branch (the "Bank") to examine the assertions in the accompanying the Description on China Construction Bank Singapore Branch's 2021 Transition Bond (the "Description"), and expressed a limited assurance conclusion on the Description.

#### Criteria

The Description is prepared in response to the Climate Transition Finance Handbook 2020 published by International Capital Market Association (the "ICMA"), in alignment with the four pillars of relevant ICMA principles as well as in consideration of the climate change mitigation transition activity classification as defined in the TEG Final Report on the EU Taxonomy, the principles of "Avoidance of Carbon Lock-in" and "Do No Significant Harm".

## Management's Responsibility

The management of the Bank (the "Management") is responsible for:

- Preparation of the Description in response to the Climate Transition Finance Handbook 2020 published by International Capital Market Association (the "ICMA"), in alignment with the four pillars of relevant ICMA principles as well as in consideration of the climate change mitigation transition activity classification as defined in the TEG Final Report on the EU Taxonomy, the principles of "Avoidance of Carbon Lock-in" and "Do No Significant Harm", and to ensure the fair presentation, accuracy, completeness and validity of the information contained in the Description;
- Design, implement and maintain necessary internal controls in accordance with the China Construction Bank Transition Bond Framework in response to the criteria in relation to



climate transition strategy and governance, business model environmental materiality, climate transition strategy to be science-based targets and pathways and implementation transparency as set out in the *Climate Transition Finance Handbook 2020*; Design, implement and maintain necessary internal controls in accordance with the *China Construction Bank Transition Bond Framework* referring to the criteria in relation to use and management of proceeds, project evaluation and selection, and information disclosure and reporting as set out in relevant ICMA principles and *TEG Final Report on the EU Taxonomy*.

## **Assurance Practitioner's Responsibility**

We conducted our limited assurance engagement in accordance with *International Standard on Assurance Engagements 3000 (Revised): Assurance Engagements Other than Audits or Reviews of Historical Financial Information* issued by the International Auditing and Assurance Standards Board.

Our responsibility is to express an independent limited assurance conclusion as to whether anything has come to our attention to cause us to believe that the Description, in all material respects, does not meet the Criteria.

#### **Our Procedures**

Our procedures performed included, but not limited to:

- Assessed policies and procedures established by the Bank related to the issuance of the China Construction Bank Singapore Branch's 2021 Transition Bond;
- Interviewed personnel of selected business units to understand the key matters in relation to the above policies and procedures;
- Reviewed the Bank's policies and procedures in relation to climate transition strategy and governance, business model environmental materiality, climate transition strategy to be science-based targets and pathways and implementation transparency;
- Reviewed the Bank's policies and procedures in relation to the use and management of proceeds for the China Construction Bank Singapore Branch's 2021 Transition Bond;
- Reviewed the Bank's policies and procedures in relation to how Management evaluated and selected appropriate project(s) for the China Construction Bank Singapore Branch's 2021 Transition Bond;
- Reviewed the Bank's policies and procedures in relation to how Management compiled information and disclosed appropriately for the China Construction Bank Singapore Branch's 2021 Transition Bond; and



 Checked eligibility of all the nominated projects for inclusion in the China Construction Bank Singapore Branch's 2021 Transition Bond.

#### Conclusion

Based on our procedures performed, as described in this report as of 12 April 2021, nothing has come to our attention that causes us to believe that the assertions in the Description on the climate transition strategy and governance, business model environmental materiality, climate transition strategy to be science-based targets and pathways, implementation transparency, use and management of proceeds, project evaluation and selection and information disclosure and reporting of the China Construction Bank Singapore Branch's 2021 Transition Bond, in all material respects, does not meet the Criteria.

#### Limitations

There are inherent limitations, for example, assurance engagements are based on selective testing of the information being examined and it is possible that fraud, error or non-compliance may occur and not be detected. A limited assurance engagement is substantially less in scope than a reasonable assurance engagement in relation to both the risk assessment procedures, including an understanding of internal control, and the procedures performed in response to the assessed risks. There are additional inherent risks associated with assurance over non-financial information including reporting against standards which require information to be assured against source data compiled using definitions and estimation methods that are developed by the reporting entity. Finally, adherence to the Description are subjective and will be interpreted differently by different stakeholder groups.

Our work is substantially less in scope than an audit conducted in accordance with *International Standards on Auditing* issued by the International Auditing and Assurance Standards Board. Accordingly, we do not express an audit opinion. Our assurance is limited to the China Construction Bank Singapore Branch's 2021 Transition Bond issuance, and does not include statutory financial statements. Our assurance is limited to policies and procedures in place as at 12 April 2021, ahead of the issuance of the China Construction Bank Singapore Branch's 2021 Transition Bond.

## **Use of Report**

Our responsibility in performing our procedures and reporting thereon is to the Bank only and in accordance with terms of reference for this engagement as agreed with them. The report may



not be suitable for another purpose. We do not therefore accept or assume any responsibility for any other purpose or to any other person or organization.
