Further to the circular dated 23 October 2019 (Reference: <u>CD/CDCRM/179/2019</u>), to facilitate Hong Kong Securities Clearing Company Limited (HKSCC) Clearing Participants (CPs) to prepare for the launch of NGRM in the second half of 2020, HKSCC has arranged the following briefing / workshop in January 2020:
