Subject: Orion Risk Platform Familiarsation Programme Phase 2 – Delegated Administrator

Reference is made to the circulars dated 5 January 2021 (Reference: <a href="CD/CDCRM/008/2021">CD/CDCRM/008/2021</a>) and 9 February 2021 (Reference: <a href="CD/CDCRM/062/2021">CD/CDCRM/062/2021</a>). The Orion Risk Platform (ORP) Familiarisation Programme Phase 1 has been launched in January 2021 and Clearing Participants (CPs) should have been studying their daily margin reports and the one-off initial margin analysis report retrieved from Report Access Platform (RAP) in the past few months. Hong Kong Securities Clearing Company Limited (HKSCC) is planning for Phase 2, which is scheduled to launch in Q3 2021 tentatively, covering:

- (i) Retrieval and study of stress testing and Default Fund<sup>1</sup> contribution related reports; and
- (ii) Access to ORP Online for margin and stress test simulation purposes.

To prepare for Phase 2, CPs are advised to:

- (i) Apply for Delegated Administrators for ORP Online (ORP DAs) by submitting the ORP DA application form via <u>Client Connect</u> (eService ID: DA 1) by your Client Connect Delegated Administrators (CCDAs) or Business users with the access right EU\_UserMaintenance <u>on or before 11 June 2021</u>. Each CP should appoint <u>at least 2 ORP DAs</u> to act as a maker and a checker to maintain the user profiles of their designated users for accessing ORP Online;
- (ii) Upon receipt of the ORP DAs from HKSCC, arrange technical setup for ORP Online, verify the connectivity and change the passwords of ORP DAs after the first login;

- (iii) Study ORP Online User Guide for margin and stress test simulation; and
- (iv) Visit the <u>web corner</u> regularly for the latest information, including ORP Familiarisation Programme Information Package, ORP Online technical information and Report Specifications.

During the Familiarisation Programme Phase 2, HKSCC will grant ORP DAs with the access to ORP Online as in production so as to facilitate CPs to access ORP for margin and stress testing simulation. ORP DAs of CPs can also set up additional designated users to access ORP Online if required for business launch.

CPs are also reminded to retrieve the one-off initial margin analysis report via RAP as soon as possible, the availability of such analysis report have been extended to <u>4 Jun 2021</u>. For those CPs who have yet to apply for user ID to access RAP, please submit a duly signed <u>HKSCC Report Access Platform (RAP) Registration Form</u><sup>2</sup> to HKSCC to ensure you can retrieve your own analysis report before the above-mentioned date.

For effective communication, HKSCC will provide regular updates, latest information and upcoming activities directly to your nominated Project Coordinators. In case you have yet to nominate your Project Coordinators (CPs are recommended to nominate two, i.e. Primary and Secondary contacts), or wish to update the Project Coordinators, please send an email to <a href="MG\_PostTrade@hkex.com.hk">MG\_PostTrade@hkex.com.hk</a> with your Participant ID, the names, titles, emails and contact numbers of your nominated Project Coordinators at once.
