The Exchange is pleased to announce that an additional 36 Stock Options Classes have been approved by the Securities and Futures Bureau, Financial Supervisory Commission (“FSC”) of Taiwan to be included in the list of “Foreign Contracts for which Futures Commission Merchants have Trading Authorization - 期貨商得受託從事期貨交易之契約” (“the List”) on 11 February 2014.

With immediate effect, Taiwan investors may now trade a total of 40 Stock Options Classes out of the 74 Stock Options Contract listed in the Stock Exchange of Hong Kong Limited (Please refer to Appendix 1, or the options class list at http://www.hkex.com.hk/eng/prod/drprod/so/classlist_so.htm in HKEx Stock Options Corner).
