Subject: **Operating System Upgrade for HKATS Network Gateway**

Reference is made to the circular (Ref: EFIC/DT/058/2014) dated 31 March 2014, Hong Kong Exchanges and Clearing Limited (“HKEx”) plans to upgrade the Linux operating system of Network Gateway(s) (“NG”) from version 6.2 to version 6.4 in mid-2014.

The upgrade will be performed by HKEx remotely in batch of Saturdays on 3, 10 and 17 May 2014 respectively. Exchange Participants (“EPs”) are required to note the following key points for the upgrade:

1. Ensure the NG remained powered on at all times during weekends (as per normal arrangement); and
2. NG may be re-booted several times during the upgrade and HKEx will verify the connectivity after the upgrade remotely; and
3. EPs are NOT required to arrange onsite support for the upgrade, nonetheless HKEx will contact the designated personnel in case of emergency; and
4. EPs are required to possess valid software maintenance subscription of Red Hat Enterprise Linux and Symantec AntiVirus Endpoint Protection for Linux according to usage requirements of Network Gateway.

As a pre-requisite for the upgrade, please complete and return the attached Confirmation Form in Appendix 1 to HKEx by fax at 2509 0724 or 2877 0017 or email to clicksupport@hkex.com.hk on or before 30 April 2014. EPs will be notified the exact upgrade schedule by email in due course.
