business day before the Commencement Day. The following pre-launch arrangements for the new stock option classes will be implemented on **30 June 2014**:

- a. Stock option series of the new stock option classes will be displayed, but not tradable; and
- b. RPF, clearing and open interest reports on new stock option classes will be generated.

The purpose of the generation of RPF one business day before the Commencement Day is to assist Participants to estimate margin requirements at Clearing House and client levels for the new stock option classes trading on the Commencement Day.

Please note that the margin requirements estimated using the RPF available after the settlement process on the business day before the Commencement Day may not be the same as the actual amounts required after the close of trading on the Commencement Day and HKEx and its subsidiaries accept no liability whatsoever for any loss or damage arising from or in connection with the use of these information contained in such RPF. Participants who wish to use the above-mentioned RPF are reminded to update the PC-SPAN Organisation Master File. For details, please refer to relevant Clearing House circular to be issued in due course.

Trading Information

The access codes of information vendors for the new stock option classes will be available on the HKEx's website (<http://www.hkex.com.hk>) in due course.

Participants are required to notify their staff and all interested clients about the upcoming introduction of new stock option classes and **pay special attention that the Contract Sizes of China Cinda Asset Management Co., Ltd stock options and GCL-Poly Energy Holdings Ltd. stock options will be in multiple board lots of their underlying securities**, and ensure that their back office systems are ready to support their trading.
