Pursuant to the share subdivision timetable issued by Fornton Group Limited ("Fornton Group"), the share subdivision of 1 share of HK\$0.01 each in Fornton Group into 2 subdivided shares of HK\$0.005 each will become effective on 6 March 2014.

Amongst other terms and conditions, Fornton Group's share subdivision is subject to the passing of relevant resolution(s) to approve the share subdivision at the Special General Meeting to be held on 5 March 2014. Shareholders, investors and market participants should read the Fornton Group's circulars and regulatory announcements in full including the terms and conditions of Fornton Group's share subdivision in dealing with Fornton Group's shares. R = Ratio of Share Subdivision, i.e. 1/2
