Pursuant to the open offer timetable issued by Solartech International Holdings Limited ("Solartech International"), Solartech International's shares (stock code: 1166) will be marked "ex-open offer" on 17 March 2014, the Ex-All Date.

Amongst other terms and conditions, Solartech International's open offer is subject to the passing of relevant resolution(s) to approve the open offer (the "Resolution(s)") at its Special General Meeting to be held on 13 March 2014 (the "SGM"). Solartech International will make a further announcement containing the results of the Resolution(s) following the SGM. Shareholders, investors and market participants should read the Solartech International's announcements, circulars and prospectus documents in full including the terms and conditions of the open offer of Solartech International in dealing with Solartech International's shares. If they are in doubt, they should consult their professional adviser(s).

Further, as an AMS/3 standard practice for ex-open offer ("Ex-All") and for reference only, an Adjusted Previous Closing Price will be displayed in the "PRV CLOSE" field of Solartech International's AMS/3 stock page on 17 March 2014, the Ex-All Date. The unadjusted previous closing price will instead be displayed in the free text field. Calculation of the Adjusted Previous Closing Price will be based on Solartech International's closing price on 14 March 2014 (i.e. last cum-all trading day) and by using the following standard adjustment formula for open offer generally.

Adjustment Formula:

Adjusted Previous Closing Price

= [(Closing Price on the last cum-all trading day x Y) + (S x X)] \div (X + Y)

where:

- S Subscription price per offer share, i.e. HK\$0.12 =
- Х = Number of offer shares a shareholder is entitled to subscribe when he/she holds Y existing shares on the record date, i.e. 5 offer shares
- Y = Number of existing shares a shareholder has to hold on the record date for entitling him/herself to subscribe for X offer shares, i.e. 1 share

Note: Price adjustment for open offer will not be made and the previous closing price will remain unchanged on ex-all date when the subscription price is higher than the closing price of the shares on the last cum-all trading day.
