Pursuant to the capital reorganisation timetable issued by EDS Wellness Holdings Limited (“EDS Wellness”), the capital reorganisation which comprises the capital reduction of nominal value of the existing shares from HK\$0.10 each in EDS Wellness to HK\$0.001 each and the share consolidation of 100 shares of HK\$0.001 each into 1 consolidated share of HK\$0.10 each will become effective on 13 May 2014. Shareholders, investors and market participants should read the EDS Wellness’s circulars and regulatory announcements in full including the terms and conditions of EDS Wellness’s capital reorganisation in dealing with EDS Wellness’s shares. If they are in doubt, they should consult their professional adviser(s).

Calculation of the Adjusted Previous Closing Price will be based on EDS Wellness’s closing price on 12 May 2014 (i.e. the day immediately before the capital reorganisation becoming effective) and by using the following standard adjustment formula for share consolidation generally.

Adjustment Formula:

Adjusted Previous Closing Price

= Closing Price on the day immediately before the capital reorganisation becoming effective x R

where:

R = Ratio of Share Consolidation, i.e. 100/1
