Pursuant to the share subdivision timetable issued by Tencent Holdings Limited ("Tencent"), the share subdivision of 1 share of HK\$0.0001 each in Tencent into 5 subdivided shares of HK\$0.00002 each will become effective on 15 May 2014.

Amongst other terms and conditions, Tencent's share subdivision is subject to the passing of relevant resolution(s) to approve the share subdivision at the Annual General Meeting to be held on 14 May 2014. Shareholders, investors and market participants should read the Tencent's circulars and regulatory announcements in full including the terms and conditions of Tencent's share subdivision in dealing with Tencent's shares. If they are in doubt, they should consult their professional adviser(s).

Further, as an AMS/3 standard practice for share subdivision and for reference only, an Adjusted Previous Closing Price will be displayed in the "PRV CLOSE" field of Tencent's AMS/3 temporary stock page (stock code: 2988) on 15 May 2014. Calculation of the Adjusted Previous Closing Price will be based on Tencent's closing price on 14 May 2014 (i.e. the day immediately before the share subdivision becoming effective) and by using the following standard adjustment formula for share subdivision generally.

Adjustment Formula:

Adjusted Previous Closing Price = Closing Price on the day immediately before Share Subdivision becoming effective x R

where: R = Ratio of Share Subdivision, i.e. 1/5
