Pursuant to the capital reorganisation timetable issued by M Dream Inworld Limited ("M Dream"), the capital reorganisation which comprises the share consolidation of 4 shares of HK\$0.10 each in M Dream into 1 consolidated share of HK\$0.40 each and the capital reduction of nominal value of the consolidated shares from HK\$0.40 each to HK\$0.01 each will become effective on 18 July 2014.

Amongst other terms and conditions, M Dream's capital reorganisation is subject to the passing of relevant resolution(s) to approve the capital reorganisation at the Special General Meeting to be held on 17 July 2014. Shareholders, investors and market participants should read the M Dream's circulars and regulatory announcements in full including the terms and conditions of M Dream's capital reorganisation in dealing with M Dream's shares. If they are in doubt, they should consult their professional adviser(s).

Further, as an AMS/3 standard practice for share consolidation and for reference only, an Adjusted Previous Closing Price will be displayed in the "PRV CLOSE" field of M Dream's AMS/3 temporary stock page (stock code: 8397) on 18 July 2014. Calculation of the Adjusted Previous Closing Price will be based on M Dream's closing price on 17 July 2014 (i.e. the day immediately before the capital reorganisation becoming effective) and by using the following standard adjustment formula for share consolidation generally.

Adjustment Formula:

Adjusted Previous Closing Price

= Closing Price on the day immediately before the capital reorganisation becoming effective x R

where:

R = Ratio of Share Consolidation, i.e. 4/1

For illustration purpose, depending on M Dream's closing price on 17 July 2014, the Exchange shall base on the above standard formula for share consolidation generally to calculate and display the Adjusted Previous Closing Price on M Dream's AMS/3 temporary stock page on 18 July 2014 as follows:-
