Pursuant to the capital restructuring timetable issued by Proview International Holdings Limited ("Proview International"), the capital restructuring which comprises the capital reduction of nominal value of the existing shares from HK\$0.10 each in Proview International to HK\$0.01 each and the share consolidation of 10 shares of HK\$0.01 each into 1 consolidated share of HK\$0.10 each will become effective on 24 July 2014.

Amongst other terms and conditions, Proview International's capital restructuring is subject to the passing of relevant resolution(s) to approve the capital restructuring at the Special General Meeting to be held on 23 July 2014. Shareholders, investors and market participants should read the Proview International's circulars and regulatory announcements in full including the terms and conditions of Proview International's capital restructuring. If they are in doubt, they should consult their professional adviser(s).

Further, as an AMS/3 standard practice for share consolidation and for reference only, an Adjusted Previous Closing Price will be displayed in the "PRV CLOSE" field of Proview International's AMS/3 stock page (stock code: 334) on 24 July 2014. Calculation of the Adjusted Previous Closing Price will be based on Proview International's closing price on 23 July 2014 (i.e. the day immediately before the capital restructuring becoming effective) and by using the following standard adjustment formula for share consolidation generally.

Adjustment Formula:

Adjusted Previous Closing Price = Closing Price on the day immediately before the capital restructuring becoming effective x R

where: R = Ratio of Share Consolidation, i.e. 10/1
