Pursuant to the capital reorganisation timetable issued by Jun Yang Solar Power Investments Limited ("Jun Yang Solar"), the capital reorganisation which comprises the share consolidation of 4 shares of HK\$0.02 each in Jun Yang Solar into 1 consolidated share of HK\$0.08 each and the capital reduction of nominal value of the consolidated shares from HK\$0.08 each to HK\$0.01 each will become effective on 12 August 2014.

Amongst other terms and conditions, Jun Yang Solar's capital reorganisation is subject to the passing of relevant resolution(s) to approve the capital reorganisation at the Special General Meeting to be held on 11 August 2014. Shareholders, investors and market participants should read the Jun Yang Solar's circulars and regulatory announcements in full including the terms and conditions of Jun Yang Solar's capital reorganisation in dealing with Jun Yang Solar's shares. If they are in doubt, they should consult their professional adviser(s).

Further, as an AMS/3 standard practice for share consolidation and for reference only, an Adjusted Previous Closing Price will be displayed in the "PRV CLOSE" field of Jun Yang Solar's AMS/3 temporary stock page (stock code: 2924) on 12 August 2014. Calculation of the Adjusted Previous Closing Price will be based on Jun Yang Solar's closing price on 11 August 2014 (i.e. the day immediately before the capital reorganisation becoming effective) and by using the following standard adjustment formula for share consolidation generally.

Adjustment Formula:

Adjusted Previous Closing Price

= Closing Price on the day immediately before the capital reorganisation becoming effective x R

where:

R = Ratio of Share Consolidation, i.e. 4/1
