Pursuant to the capital reorganisation timetable issued by Sinogreen Energy International Group Limited (“Sinogreen Energy”), the capital reorganisation which comprises the share consolidation of 5 shares of HK\$0.10 each in Sinogreen Energy into 1 consolidated share of HK\$0.50 each and the capital reduction of nominal value of the consolidated shares from HK\$0.50 each to HK\$0.10 each will become effective on 12 September 2014.

Amongst other terms and conditions, Sinogreen Energy’s capital reorganisation is subject to the passing of relevant resolution(s) to approve the capital reorganisation at the Special General Meeting to be held on 11 September 2014. Shareholders, investors and market participants should read the Sinogreen Energy’s circulars and regulatory announcements in full including the terms and conditions of Sinogreen Energy’s capital reorganisation in dealing with Sinogreen Energy’s shares. If they are in doubt, they should consult their professional adviser(s).

Further, as an AMS/3 standard practice for share consolidation and for reference only, an Adjusted Previous Closing Price will be displayed in the “PRV CLOSE” field of Sinogreen Energy’s AMS/3 temporary stock page (stock code: 2945) on 12 September 2014. Calculation of the Adjusted Previous Closing Price will be based on Sinogreen Energy’s closing price on 11 September 2014 (i.e. the day immediately before the capital reorganisation becoming effective) and by using the following standard adjustment formula for share consolidation generally.

Adjustment Formula:

Adjusted Previous Closing Price

= Closing Price on the day immediately before the capital reorganisation becoming effective x R

where:

R = Ratio of Share Consolidation, i.e. 5/1
