Pursuant to the share consolidation timetable issued by Merdeka Mobile Group Limited (“Merdeka Mobile”), the share consolidation of 8 shares of HK\$0.01 each in Merdeka Mobile into 1 consolidated share of HK\$0.08 each will become effective on 29 September 2014.

Amongst other terms and conditions, Merdeka Mobile’s share consolidation is subject to the passing of relevant resolution(s) to approve the share consolidation at the Extraordinary General Meeting to be held on 26 September 2014. Shareholders, investors and market participants should read the Merdeka Mobile’s circulars and regulatory announcements in full including the terms and conditions of Merdeka Mobile’s share consolidation in dealing with Merdeka Mobile’s shares. Adjustment Formula:

Adjusted Previous Closing Price

= Closing Price on the day immediately before Share Consolidation becoming effective x R

where:

R = Ratio of Share Consolidation, i.e. 8/1
