Pursuant to the share consolidation timetable issued by China Environmental Energy Investment Limited (“China Environmental Energy”), the share consolidation of 20 shares of HK\$0.0005 each in China Environmental Energy into 1 consolidated share of HK\$0.01 each will become effective on 3 October 2014.

Amongst other terms and conditions, China Environmental Energy’s share consolidation is subject to the passing of relevant resolution(s) to approve the share consolidation at the Special General Meeting to be held on 30 September 2014. Shareholders, investors and market participants should read the China Environmental Energy’s circulars and regulatory announcements in full including the terms and conditions of China Environmental Energy’s share consolidation in dealing with China Environmental Energy’s shares. If they are in doubt, they should consult their professional adviser(s).

Further, as an AMS/3 standard practice for share consolidation and for reference only, an Adjusted Previous Closing Price will be displayed in the “PRV CLOSE” field of China Environmental Energy’s AMS/3 temporary stock page (stock code: 2956) on 3 October 2014. Calculation of the Adjusted Previous Closing Price will be based on China Environmental Energy’s closing price on 30 September 2014 (i.e. the day immediately before the share consolidation becoming effective) and by using the following standard adjustment formula for share consolidation generally.

Adjustment Formula:

Adjusted Previous Closing Price
= Closing Price on the day immediately before Share Consolidation becoming effective x R

where:

R = Ratio of Share Consolidation, i.e. 20/1
