Pursuant to the share consolidation timetable issued by Kantone Holdings Limited (“Kantone”), the share consolidation of 10 shares of HK\$0.10 each in Kantone into 1 consolidated share of HK\$1 each will become effective on 16 December 2014.

Amongst other terms and conditions, Kantone’s share consolidation is subject to the passing of relevant resolution(s) to approve the share consolidation at the Extraordinary General Meeting to be held on 15 December 2014. Shareholders, investors and market participants should read the Kantone’s circulars and regulatory announcements in full including the terms and conditions of Kantone’s share consolidation in dealing with Kantone’s shares. If they are in doubt, they should consult their professional adviser(s).

Further, as an AMS/3 standard practice for share consolidation and for reference only, an Adjusted Previous Closing Price will be displayed in the “PRV CLOSE” field of Kantone’s AMS/3 temporary stock page (stock code: 2905) on 16 December 2014. Calculation of the Adjusted Previous Closing Price will be based on Kantone’s closing price on 15 December 2014 (i.e. the day immediately before the share consolidation becoming effective) and by using the following standard adjustment formula for share consolidation generally.

Adjustment Formula:

Adjusted Previous Closing Price

= Closing Price on the day immediately before Share Consolidation becoming effective x R

where:

R = Ratio of Share Consolidation, i.e. 10/1
