Chun Wo Development Holdings Limited (“Chun Wo”) announced a distribution in specie of shares of Excel Value International Limited (“Excel Value”) to its qualifying shareholders on the basis of 1 share of Excel Value for every 1 share held on the record date (the “Distribution in Specie”).
