Data structure

Securities Master File (to-be-listed) in JavaScript Object Notation (.json) format is available before trading commences to provide the latest information on to-be-listed securities eligible for trading on the day after next trading day. It also covers securities with temporary or multiple counters where the first trading date is on the day after next trading day.

The securities list and attributes in this file are based on the latest information obtained when the file is generated. As there may be changes before the listing date, updated information will be reflected on Securities Master File.

APPENDIX 1

Unique Stock Identifier ("Stock ID")

Stock ID is a unique stock identifier assigned to a stock of securities. The stock ID is essential because (i) it identifies the same company regardless of changes of the company name or changes of the Exchange designated stock code ("stock code"); and (ii) it distinguishes different companies with the same stock code.

EXAMPLES

Same company with different company names

APPENDIX 3

Definition of red-chips

A company is deemed to be a China-controlled company (Red Chip), if

- (1) The company has at least 30% shareholding held in aggregate directly by Mainland China entities, and/or through companies which are controlled by Mainland China entities. Or
- (2) The company has below 30% but 20% or above shareholding held in aggregate directly by Mainland China entities, and/or through companies which are controlled by Mainland China entities and, there is a strong influential presence, on a judgmental basis, on the company's board of directors.

Mainland China entities include state-owned organisations and entities controlled by provincial or municipal authorities.
