#### 1. Overview

Entitlement Record (Main Board) 1970 - 1986 is one of the electronic data products published on compact diskette by Hong Kong Exchanges and Clearing Ltd. It is basically a collection of all announcements made by the listed issuers on the Main Board of The Stock Exchange of Hong Kong ("the Exchange") in relation to shareholders' entitlements.

Entitlement Record (Main Board) 1970 - 1986 covers entitlement announcements made in the period from 1970 to March 1986. Some data will not be available in this product due to different approaches in capturing data before the formation of the Exchange. Nevertheless, this product will meet the demand of market participants and general investors for an extensive entitlement history of Hong Kong listed companies.

The scope of Entitlement Record (Main Board) 1970 – 1986 is confined to entitlements to holders of equity shares (including ordinary shares and preference shares).

In addition to information on shareholders' entitlements, Entitlement Record (Main Board) 1970 - 1986 also provides details on announcements effecting capital changes. In short, it covers the following types of announcements:

- Entitlements of shareholders, such as dividend, bonus issue, rights issue, etc
- > Stock split
- Stock consolidation



### 2. File Description

Each Entitlement Record (Main Board) 1970 - 1986 CD contains two files, a data file and a report file. The two files have the same data coverage but are different in format to suit different usage.

The Entitlement Record (Main Board) 1970 - 1986 in both files are arranged in sequence of a unique stock identifier ("stock ID", please refer to Appendix B for details) and the announcement date.

#### 2.1 Data File

The data file is a fixed-length text file. It contains 2 types of records, namely, header record and detail record. The first record in the file is a header record while the remaining others are all detail records.

### **Header Record**

- > The first record in the data file
- Contains only column headings in text (data field names)
- Makes it convenient for user to view the data file after opening it in a spreadsheet application, such as Microsoft EXCEL, for further processing
- > Total data length 361 bytes

#### **Detail Record**

- Contains details of an entitlement as described in Table 1
- Data fields are delimited by a space character
- Sometimes an announcement may be represented by separate records in the data file. The separation is due to the followings limitations on the data file:
  - (i) 6 lines of entitlement details are not sufficient to store the full details of the announcement
  - (ii) a single book closed period, a single payable date or a single ex-date is not sufficient for more than one entitlement announced at the same time
- > Sorted in sequence of stock ID and announcement date
- Total data length 361 bytes

# 2.2 Report File

- Presents the data in a formatted report
- Report heading and column headings are repeated for each page break
- > Combines details of the same announcement which are represented by separate records in the data file.
- > Sorted in sequence of stock ID and announcement date

#### **GLOSSARY**

**Book close date - from** First day (inclusive) in the book close period

**Book close period** Period in which no transfer of "the shares" would be registered.

Only transfer of "the shares" lodged for registration before this

period would qualify the shareholder for the entitlement

**Book close date - to**Last day (inclusive) in the book close period. Blank if the period

only last for 1 day.

**Ex date** Day from which onwards buyers of "the shares" would not receive

the entitlement announced

Financial year end Last day in the financial year respective to the entitlement

announcement

Payable date Payable day of the dividend

**Security type code** Code to indicate the type of securities :

0101 Ordinary share - Ordinary company

0102 Ordinary share - Investment company

0201 Preference share

0303 Derivative warrant

0501 Exchange Traded Fund / Real Estate Investment Trust

**Stock code** Code assigned to the security for trading on the Exchange. This

code is not unique since codes assigned to delisted securities can

be re-used.

Stock ID Unique stock identifier (please see Appendix B for details)

"the shares" The equity shares respective to the entitlement announcement



#### **APPENDIX B**

### **Unique Stock Identifier ("Stock ID")**

Stock ID is a unique stock identifier assigned to a stock of securities. The stock ID is essential because (i) it identifies the same company regardless of changes of the company name or changes of the Exchange designated stock code ("stock code"); and (ii) it distinguishes different companies with the same stock code.

#### **EXAMPLES**

### Same company with different company names
