HKEx Orion Market Data Platform – Securities Market & Index Feed Products (OMD-C)
Technical Document Updates for Volatility Control Mechanism and Closing Auction Session

Following the announcement by Hong Kong Exchanges and Clearing Limited (HKEx) on 3 July 2015 of its plan to proceed with the implementation of the Volatility Control Mechanism (VCM) in its securities and derivatives markets and the Closing Auction Session (CAS) in its securities market, the following documents have been updated corresponding to the final models of VCM and CAS in the securities market and provided herewith for your reference.
