<u>Changes to HKEX Orion Market Data Platform - Derivatives Market (OMD-D) for 2018:</u> (A) Introduction of New Market State; and (B) HKATS and DCASS Upgrade

We would like to inform you of the following upcoming changes to OMD-D planned for 2018.

(A) Introduction of New Market State

A new market state "28" for "SUSPEND" (this description is subject to change) may be introduced in the <u>first quarter of 2018</u> the earliest. Initially, this market state will be used at **Series Level** (i.e. as Instrument Session State, or ISS). Clients and ISVs are requested to review their applications and ensure this new market state would not adversely affect the applications when put in use. A set of canned data with this new ISS will be distributed to Clients and ISVs in the third quarter of 2017.

Clients and ISVs are reminded to avoid any hardcoding when processing market states and ensure that their applications will not be affected when HKEX introduces new market states to reflect new Trading Session States (TSS) or ISS.

For more details about TSS and ISS, please read the respective section in the OMD-D Developers Guide (Section 5.2.3.1) of which a revised version is enclosed for your reference.

(B) HKATS/DCASS Upgrade

Following the briefings on HKATS and DCASS Upgrade ("HKATS/DCASS Upgrade") in June this year, we would like to provide you more details about the changes to OMD-D for this initiative of HKEX. The changes will be done in two phases with the scopes summarised below.

Phase 1 - Rollout : 2 nd Quarter (Q2) 2018	Phase 2 - Rollout : 3 rd Quarter (Q3) 2018	
Addition of new reference data including HKATS Root Symbol (also known as Underlying Code) and Tick Size, etc.	 Changes for the HKATS/DCASS Upgrade, which can be addition of new data fields, new attributes or new usages of existing fields, etc. Interface Specification and other technical documents, if any, to be provided in September 2017
