Connectivity Session and Market Rehearsals for the implementation of Orion Trading Platform for Securities Market (OTP-C)

Our notices of 16 February 2017 (Our Ref: MDD/17/198) and 4 July 2017 (MDD/17/830) informing you of HKEX's plan to introduce new trading platform, namely Orion Trading Platform for Securities Market (OTP-C), for its Securities Market refer please.

Please be informed that Test Sessions, including a Connectivity Session (CS) and two Market Rehearsals (MRs), will be held as per the table below:

^{*} Dissemination of the OMD-C message Security Status (21), both real-time and the refresh snapshot service, will also fall back to the original channels after the fallback processes.

Please refer to attached relevant Participant Circular and Information Pack for more information. OMD-C Clients who are interested in joining any of the Test Sessions, please complete and submit the online registration forms **on or before 31 October 2017**.



Clients are reminded that the multicast channels for the real-time dissemination and refresh snapshot service of the OMD-C message Security Status (21) will be changed upon the launch of OTP-C and therefore will be applied in the Test Sessions. Although it is expected that this change would be transparent to most Clients, participating Clients should nonetheless ensure their OMD-C applications can function normally during and after the Test Sessions.

Last but not the least, please be informed that volume test sessions are arranged for the CS and the MRs on reserved stocks 6400 - 6499. However, market data dissemination, including reference data, security status, order book, trade and trading statistics, of the stocks in this range would be suppressed and would not be disseminated through OMD-C.
