Market Data of the New Stock Futures Contracts and New Stock Options Classes

a) Market Data Transmission

The trading information on the new stock futures contracts and new stock options classes will be transmitted via OMD-D upon the product launch on 3 July 2018 and 16 July 2018 respectively. The final strike information of the new stock options will also be provided to Clients shortly after the close of the day session (at around 6:30 p.m.) on 13 July 2018. Please note that the information will also be available on OMD-D via Reference Data messages.

b) Pre-launch Arrangement

Due to the pre-launch arrangement implemented for new stock futures contracts on Friday 29 June 2018, OMD-D messages of certain message types may include the new stock futures contracts on 29 June 2018. However, the new stock futures contracts will not be tradable on that day.

Similarly, OMD-D messages of certain message types may include the new stock options classes on Friday 13 July 2018 but the new stock options classes will not be tradable on that day.

c) Vendor Access Codes Confirmation

For publicity purpose, please complete and return the attached Vendor Access Code Confirmation Form on or before Friday, 22 June 2018 and keep us updated if there is any change. The access codes collected will be published on the HKEX website. (If you have reviewed the access codes on our website and discovered that the access code for any other product is not updated, please also let us know.)

Clients and ISVs are reminded to make appropriate adjustments and arrangements where necessary to ensure the readiness of their systems for the above changes to the stock futures and options markets on time.
