<u>Updates on HKEX Orion Market Data Platform - Derivatives Market (OMD-D) for HKATS and</u> <u>DCASS Upgrade – Phase 2 Change</u>

References are made to the notices dated 15 February 2018 (Our Ref: <u>MDD/18/853</u>), 7 May 2018 (Our Ref: <u>MDD/18/1170</u>), 14 May 2018 (Our Ref: <u>MDD/18/1242</u>), 26 July 2018 (Our Ref: <u>MDD/18/1665</u>) and 9 August, 2018 (Our Ref: <u>MDD/18/1922</u>), regarding the Phase 2 Change to OMD-D for HKATS and DCASS Upgrade ("HKATS/DCASS Upgrade").

I. Declaration of Readiness Status

All Clients and ISVs are required to declare their system readiness status for the Phase 2 Change by returning us the duly signed declaration form as enclosed by **4 January 2019**. For your information, a checklist which summarises the changes to OMD-D messages in the Phase 2 Change from the Interface Specification is provided in the declaration form. Clients and ISVs should ensure that all of the changes are accommodated in their systems before testing.

II. Testing Arrangement for Phase 2 Change

The following testing facilities are arranged for Clients and ISVs to conduct testing for the declaration:

Canned Data for Off-line Testing

A canned data set illustrating the changes for Phase 2 has been prepared and ready to be downloaded via <u>this link</u>. Clients or their appointed ISVs can make use of the canned data set to conduct off-line testing with the OMD-D Off-line Simulator Tool. An answer book is also provided to enable Clients and ISVs to verify their test results.

Readiness Test

Clients and ISVs can also make connections to the OMD-D Readiness Test Environment to receive the OMD-D messages for Phase 2 Change. The messages of the Phase 2 Change will be available in the new Session 1 of the OMD-D Readiness Test Environment every Thursday from 1 November 2018. More details on the OMD-D Readiness Test schedule & rundown, answer book and result declaration form will be provided in the <u>OMD-D web corner</u> in due course.



Please be reminded that there are some enhanced features of HKATS/DCASS Upgrade (e.g., the weekly expiry contract, 5-alpha-numeric HKATS root symbol). They have been included in the aforesaid canned data and Readiness Test Environment for your development and testing purpose.
