<u>Changes to IIS on Unifying Character Encoding and Strengthening Password</u> <u>Requirement</u>

Please be informed that the following changes to IIS will come into effect in late Q2 / early Q3 2019:

1. Unify Character Encoding to Unicode

Character encoding in all IIS headline messages and attachments will be unified to Unicode. This is different than today that both Big5 and Unicode are used for Chinese character encoding.

In order to facilitate testing for this change, a canned data set will be provided in late May / early June 2019.

2. Strengthen Password Requirement

Password requirement of IIS will be strengthened. The table below summarises the existing and new password requirement:

Item	Existing Requirement	New Requirement
Length of password	At least 6 characters Maximum 20 characters	At least 16 characters Maximum 20 characters
Complexity of password	Alphanumeric	Must contain a combination of: - Upper case letter - Lower case letter - Number - Special character
Enforce password history	Not the same as any of the last 3 passwords	Not the same as any of the last 5 passwords
