<u>Arrangement of Orion Market Data – Derivatives Market (OMD-D) for the Introduction</u> of MSCI Asia and Emerging Market Index Futures Contracts and Options Suite

With reference to the enclosed circular (Ref. No.: MKS/EQD/07/20), Hong Kong Exchanges and Clearing Limited (HKEX) plans to introduce 37 Futures and Options contracts based on the MSCI Asia and Emerging Market Indices ("the Proposed Contracts") by phases in the second half of 2020, subject to regulatory approvals and market readiness.

A canned data set illustrating the Proposed Contracts will be available in mid-June 2020. Interested Clients and ISVs could obtain the canned data set by completing the Request Form online via this link by 12 June 2020 (Friday).

Clients and ISVs are reminded to make appropriate adjustments and arrangements where necessary to ensure the readiness of their systems for the introduction of the Proposed Contracts.
