Hong Kong Exchanges and Clearing Limited (HKEX) announced the introduction of stock futures contract and stock options class on JD.com, Inc. ("JD Futures and Options"). Subject to the successful listing of JD.com, Inc. on **18 June 2020 (Thursday)**, trading of JD Futures and Options will commence on the same day.
