<u>Arrangement for the introduction of Hang Seng TECH Index Futures and Options in HKEX Orion Market Data Platform – Derivatives Market (OMD-D)</u>

With reference to the enclosed Participant Circular (Ref: MKS/EQD/32/20) from Hong Kong Futures Exchange Limited (HKFE), HKFE plans to introduce futures and options contracts based on the Hang Seng TECH Index ("the Proposed Contracts") on 23 November 2020 and 18 January 2021 respectively ("Tentative Launch Dates"), subject to the regulatory approval and the market readiness.

Please find below the Market Code, the Trading Symbol and the Commodity Code of the Proposed Contracts. We also enclose the updated OMD-D Interface Specifications (version 1.34) for updating the description of the existing Market Code "86".

The trading information on the Proposed Contracts will be transmitted via OMD-D on their Launch Dates.

b) Pre-launch Arrangement in OMD-D

The final strike information of the options contracts will be provided to Clients shortly after the close of the day session (at around 6:30 p.m.) one business day before the Launch Date by email.

The Proposed Contracts information will also be available in OMD-D via Reference Data one business day before the Launch Date, but they are not tradable on that day.
