<u>Arrangement of HKEX Orion Market Data Platform - Derivatives Market (OMD-D) for the Implementation of Derivatives Holiday Trading for MSCI Futures and Options</u>

With reference to our Client Notice issued on 27 October 2020 (Our Ref: MDD/20/884) and the enclosed Participant Circular issued by Hong Kong Futures Exchanges (HKFE) (Ref. No: MO/DT/007/22), the Derivatives Holiday Trading ("Holiday Trading") will be implemented in April 2022 to allow all MSCI Futures and Options can be traded on Hong Kong public holidays (except for the holiday of New Year's Day) starting from Good Friday, 15 April 2022, subject to the regulatory approval and market readiness.

When Holiday Trading is implemented, OMD-D will be brought up and operated as business usual on Holiday Trading Days ("H Days"). There is no change on the interface and the message structure in OMD-D. Enclosed is the updated OMD-D Interface Specification (version 1.40) with the highlights on the difference of the message behavior between a normal trading day and H Days in Appendix 1. All document changes are summarised in the change history and highlighted with "|" on the right margin in the document.

The list of all MSCI Futures and Options with market codes and commodity codes which are allowable for trading on Hong Kong public holidays is enclosed for the reference. Clients and ISVs are suggested to review their systems and operation procedure and make necessary change to ensure the readiness of their systems for the implementation of Holiday Trading, especially with the updated key values and statistics will be shown correctly.
