## <u>Updates on Introduction of Hang Seng TECH Index Futures Options and Enhancements to Hang Seng TECH Index Futures and Hang Seng TECH Index Options</u>

With reference to our client notice issued on 25 October 2022 (Ref: MDD/22/719) and the enclosed Participant Circular (Ref: MKS/EQD/14/22) for the introduction of Hang Seng TECH Index Futures Options ("HS TECH OOF") and Enhancements to Hang Seng TECH Index Futures and Hang Seng TECH Index Options (altogether "Contract Enhancements"), Hong Kong Futures Exchange Limited announced the introduction of HS TECH OOF and the Contract Enhancements will be effective from 28 November 2022 (Monday).

Due to the pre-launch arrangement, the HS TECH OOF contracts information will be available in OMD-D via Reference Data on 25 November 2022, but the contract will not be tradable on that day. The final strike information of HS TECH OOF on 28 November 2022 will also be provided to Clients around 6:30 p.m. on 25 November 2022 by email.

In addition, please be reminded that the Contract Enhancements includes the introduction of HS TECH Index Options in the After-Hours Trading ("AHT") session and the introduction of additional contract months for HS TECH Futures and HS TECH Index Options. Clients should refer to the aforementioned client notice dated 25 October 2022 for details on changes and arrangement in OMD-D, as well as the enclosed Participant Circular (Ref: <a href="MKS/EQD/14/22">MKS/EQD/14/22</a>) for the trading arrangement.

Clients and ISVs are reminded to make appropriate adjustments and arrangements where necessary to ensure the readiness of their systems for the introduction of HS TECH OOF and the Contract Enhancements.

Indirect Connection OMD-D Clients should also closely liaise with their feed providing vendors or application service providers for all necessary arrangements to ensure their readiness for the aforementioned changes.
