Upon the launch of IIS Technical Upgrade, during normal (non-failover) scenario, the new IIS server in Secondary (DR) site will also be active and disseminating the same set of data as servers in Primary site. Clients are allowed to connect the IIS server in either Primary site or Secondary site under the same dedicated Vendor identity (i.e. Username), but not concurrently.	August 2023	September 2023
Optional IIS Certification Test	 IIS Certification Test environment will be available for Clients, who have IIS testing connections, to reserve for conducting internal testing.
