Arrangement in HKEX Orion Market Data Platform – Derivatives Market (OMD-D) for Introduction of the 10-year China Ministry of Finance Treasury Bond Futures

With reference to the enclosed Exchange Circular (Ref: <u>EBF/FIC/007/23</u>), Hong Kong Futures Exchange Limited (the "Exchange" or "HKFE") plans to introduce the 10-year China Ministry of Finance Treasury Bond ("MOF T-Bond") Futures Contract. The trading of the MOF T-Bond Futures Contract is targeted to commence in Q1 2024 ("Launch Date"), subject to regulatory approval and market readiness. The actual launch date will be further announced in a separate client notice in due course.
