# <u>Updates on Issuer Information feed Service ("IIS") Technical Upgrade – Updated Implementation Schedule and IIS Transmission Specification</u>

With reference to our Client Notices issued on 9 June 2023 (Ref: MDD/23/260), 30 August 2023 (Ref: MDD/23/494) and 5 December 2023 (Ref: MDD/23/749) for the Arrangement for the Issuer Information feed Service ("IIS") Technical Upgrade, please note the following updates on the implementation schedule and IIS Transmission Specification.

### 1) Updated Implementation Schedule

Optional IIS Certification Test	IIS Certification Test environment is available for Clients, who have IIS testing connections, to reserve for conducting internal testing. Optional Practice Session ("PS")	Optional, but highly recommended to participate in the PS via production connections to ensure the readiness of the connectivity to IIS new servers before joining the market rehearsal.  Participated clients are required to follow the connectivity details in the new IIS Production Configuration Information Sheet provided in September 2023.  To confirm your participation in the PS, please complete the Online Test Participation Form by 26 January 2024 (Friday). Test rundown of the PS will be provided to the enrolled clients accordingly.	3 February 2024
<b>Mandatory</b> Market Rehearsal ("MR")	All Clients are <b>required</b> to participate in the MR.  MR schedule and details will be provided in due course.	March / April 2024 (Tentatively)
Mandatory Post Release Test ("PRT") and Production Rollout	All Clients are <b>required</b> to participate in the PRT.  PRT and production rollout schedule will be provided in due course.	April / May 2024 (Tentatively)
