Arrangement of HKEX Orion Market Data Platform - Securities Market (OMD-C) and Mainland Market Data Hub (MMDH) for the Adjustment to Market Data Dissemination in Relation to Northbound Trading under Stock Connect

With reference to the enclosed Exchange Circular (Ref: CT/038/24) from the Stock Exchange of Hong Kong Limited ("SEHK") and the news release issued by Hong Kong Exchanges and Clearing Limited (HKEX), Shanghai Stock Exchange (SSE) (in Chinese only) and Shenzhen Stock Exchange (SZSE) (in Chinese only), the market data dissemination in relation to Northbound trading under Stock Connect will be adjusted, following A-shares market practice.

## **Details of the Adjustments Relating to OMD-C and MMDH**

The adjustments relating to market data dissemination in OMD-C and MMDH for **Northbound trading** will cover the followings:

Enclosed are the updated OMD-C Interface Specifications (version 1.38) and OMD-C MMDH Interface Specifications (version 1.37) for the aforementioned changes. All document changes are summarised in the change history and highlighted with "|" on the right margin in the documents.

There is no system interface change in OMD-C and MMDH and is therefore functionally transparent to Clients and ISVs. Nevertheless, the dissemination of message content and frequency of Stock Connect Daily Quota Balance (80) and Stock Connect Market Turnover (81) messages will be changed. Clients and ISVs are therefore reminded to make appropriate adjustments and arrangements where necessary to ensure the readiness of their systems for the above implementation.

### **Implementation Timeline**

The adjustments for item 1 and 2 mentioned above will be implemented first, tentatively **1 month** after the issuance of this client notice.

There are other adjustments to market data dissemination for Northbound trading under Stock Connect which are unrelated to OMD-C and MMDH. The implementation of all other adjustments (including item 1 and 2 already implemented) is expected to take **approximately 4 months** from the date of this client notice.

## **Test Arrangements**

To facilitate Clients and ISVs to verify their own systems for the adjustments for item 1 and 2, an optional End-to-End (E2E) testing session will be held from 16 April 2024 (Tuesday) to 10 May 2024 (Friday), except on the public holidays and testing host maintenance day.

Please note that test booking for OMD-C in the E2E Test Environment is not required during the aforementioned E2E Test Session.

An optional Practice Session ("PS") will also be arranged for **27 April 2024 (Saturday)**. Clients, who would like to participate in the PS, are required to enroll in the Online Registration Form by 24 April 2024 (Wednesday). Test rundown of the PS will be provided to enrolled clients by 25 April 2024 (Thursday).

In addition, a set of canned data will be available for Clients and ISVs to test their systems with the aforementioned changes. Clients and ISVs, who are interested in obtaining the canned data set, should complete the <a href="Online Request Form">Online Request Form</a> by 16 April 2024 (Tuesday). The canned data set will be distributed to the registered clients on 17 April 2024 (Wednesday).
