## Implementation of Severe Weather Trading Starting from 23 September 2024

With reference to our Client Notice issued on 15 July 2024 (Our Ref: <a href="MDD/24/461">MDD/24/461</a>), as The Stock Exchange of Hong Kong Limited and Hong Kong Futures Exchange ("the Exchange") have obtained regulatory approval, the implementation of Severe Weather Trading ("SWT") of Hong Kong Securities and Derivatives Markets will come into effect starting from 23 September 2024 (Monday).

Upon the implementation of SWT, trading of securities and stock options at The Stock Exchange of Hong Kong Limited, including Northbound and Southbound Trading under Stock Connect, and trading of derivatives contracts at Hong Kong Futures Exchange will remain available during severe weather ("SW") conditions<sup>1</sup> <sup>2</sup>.

There will be no system changes in all market data systems<sup>3</sup> in relation to the launch of SWT, and all market data systems will be operating as usual as regular trading day during SW conditions.

Clients and ISVs are reminded to review your systems and operational arrangement, and make adjustments where necessary to get prepared for the implementation of SWT.
