Updates on Market Data Test Service Policy and Test Service Application Form

To facilitate market data testing for Exchange Participants ("EPs"), we would revise the market data test service policy as follows for (i) HKEX Orion Market Data Platform - Securities Market ("OMD-C") Clients who are EPs of The Stock Exchange of Hong Kong Limited ("SEHK") or (ii) HKEX Orion Market Data Platform - Derivatives Market ("OMD-D") Clients who are EPs of Hong Kong Futures Exchange Limited ("HKFE")/ SEHK Options Trading (collectively "EP Clients") with effect from 1 January 2025:

¹ Refers to Orion Trading Platform – Securities Market ("OTP-C")/ Hong Kong Futures Automatic Trading System ("HKATS") E2E test environment. OTP-C Prod Lite test environment is also covered.

² The charging scheme would follow the existing test charge and free testing time under Condition 2 of the

enclosed Test Application Form.



For non-EP Clients, market data test charge and test application form requirement remain unchanged.
