## **Enhancement on the Index Datafeed in Mainland Market Data Hub (MMDH)**

In order to enhance the efficiency for potential index expansion and business demands in the future, an enhancement on the Index datafeed in MMDH has been planned to be effective in **September 2026 tentatively**.

In the current production environment, MMDH publishes all data for OMD Securities Standard (“SS”), Odd Lot Order (“OLO”), Stock Connect Market (“SCM”), and Index datafeeds from the same component. Upon implementation of this enhancement, a new component dedicated to the Index datafeed will be introduced. As a result, the dissemination of index data will be separated from that of the other datafeeds and new subscriber login name(s), dedicated to connecting to the new Index datafeed component, will also be assigned to each Client.

There is no functional interface change for this enhancement. Enclosed is the updated OMD-C MMDH Developers Guide (version 2.1) for this enhancement. All document changes are summarised in the change history and highlighted with “|” on the left margin in the documents.

Please find the high-level changes provided in the table below for your easy reference.
