Arrangement in HKEX Orion Market Data Platform – Derivatives Market (OMD-D) for Introduction of the 5-Year China Government Bond Futures

With reference to our client notice issued on 27 March 2024 (Our Ref: [MDD/24/230](#)) regarding the introduction of the 10-year China Ministry of Finance Treasury Bond Futures Contract, following an evaluation of market demand and macro environment, Hong Kong Futures Exchange Limited announced its intention to introduce the 5-Year China Government Bond (“CGB”) Futures Contract on **3 August 2026 (Monday)** (“Launch Date”), subject to regulatory approval and market readiness.

Please find below the Market Code, the Trading Symbol and the Commodity Code of the CGB Futures Contracts below, as well as the enclosed Exchange Circular (Ref: [FIC/004/26](#)) for trading information.

The enclosed OMD-D Interface Specification (version 1.49) is also updated to reflect the new description of the corresponding market code.

i. Market Data Transmission

Trading information on the CGB Futures Contracts will be transmitted via OMD-D upon the product launch on the Launch Date respectively.

The previously suspended Five-Year Ministry of Finance Treasury Bond Futures will also be delisted upon the introduction of the CGB Futures Contracts.

ii. Pre-launch Arrangement

In OMD-D, the information of the CGB Futures Contracts will be available via Reference Data messages one business day before the Launch Date, but they will not be tradable on that day.

iii. Vendor Access Codes Confirmation

For publicity purpose, Information Vendors (IVs), who plan to provide and display the information of the CGB Futures Contracts in their service(s) after the product launch, please complete and return the attached Vendor Access Code Confirmation Form on or before **10 July 2025 (Friday)** and keep us updated if there is any change. The access codes collected may be published on the HKEX website and/or any promotional materials.

Separately, if you have reviewed the access codes on our website and discovered that the access code for any other product is not up to date, please inform us.

Clients and ISVs are reminded to make appropriate adjustments and arrangements where necessary to ensure the readiness of their systems for the introduction of the CGB Futures Contracts.
