# Guiding Note on Use of Index Information Supplied by China Securities Index Company Limited (for Real-time Licensed Information Vendors)

PURPOSE

Pursuant to clause 10.6 of the Market Data Vendor Licence Agreement, HKEX-IS shall notify the vendors on the requirement on the use of the Third Party Content. This guiding notes sets out the requirement on the use of index information supplied by China Securities Index Company Limited ("CSIC") which is being carried through the information systems of HKEX Information Services Limited ("HKEX-IS").

### DETAILS

CSIC (for itself in respect of the CSIC Indexes, as agent of the Shanghai Stock Exchange in respect of the SSE Indexes and as agent of China Exchanges Services Company Limited ("CESC") in respect of the CESC Indexes) has granted a license to HKEX-IS to provide to real-time securities market data services vendors the indexes listed in Schedule 1 to this note ("Indexes", and the term "Index Information" shall mean information relating to any of the Indexes).

The Index Information is provided to vendors on the terms and conditions of the Market Data Vendor Licence Agreement, unless otherwise provided in this note, and vendors are deemed to have accepted these terms and conditions by their taking delivery and use of such Index Information. If there are any inconsistencies between the Market Data Vendor Licence Agreement and this note, the provisions of this note shall prevail. Accordingly, vendors shall be bound to acknowledge and observe the following terms and conditions notwithstanding any provisions to the contrary in the Market Data Vendor Licence Agreement:

- 1. CSIC, the Shanghai Stock Exchange and CESC are the respective proprietors and owners of all the rights, title, goodwill and interest in the CSI Indexes and CSI Marks, the SSE Indexes and SSE Marks and the CESC Indexes and CESC Marks; and CSIC, the Shanghai Stock Exchange and CESC have registered and/or applied to register some of their respective marks in Hong Kong and elsewhere. The Information Vendor by receiving the Index Information from HKEX-IS is deemed to have acknowledged such rights and to have agreed to comply with the stipulations and obligations below and not to do any act inconsistent with such rights.
- 2. The Indexes are classified into two categories, namely Redistributable Indexes and Non-redistributable Indexes as listed in Schedule 1 of this note, and the terms Redistributable Index Information and Non-redistributable Index Information shall be construed accordingly. Vendors shall not use or disseminate the Index Information except as set forth below.

### Redistributable Index Information

2.1 Vendors are permitted to use the Redistributable Index Information received from HKEX-IS (directly or indirectly) for their internal use and to disseminate such information at no charge to their Subscribers for their internal use only and not for further dissemination.

### Non-redistributable Index Information

2.2 Non-redistributable Index Information is, on the contrary, disseminated to vendors solely for their internal use. Vendors must not further disseminate all or part of the Non-redistributable Index Information to their Subscribers or any other persons (whether or not for remuneration) unless vendors have obtained the prior written approval of, or have entered into a license agreement with, CSIC or its designated agent. The designated agent of CSIC may change from time to time subject to CSIC's appointment.

- 3. HKEX-IS and CSIC do not guarantee the accuracy and/or completeness of the Index Information, nor do they give any express or implied warranties with respect to the Index Information.
- 4. Neither HKEX-IS nor shall CSIC be liable for any damages, loss, costs and expenses caused by any error, omission, negligence or delay in compiling or disseminating the Index Information.
- 5. The Index Information may be amended from time to time and HKEX-IS may cease providing all or any of the Index Information at any time by giving 30 days' notice or, if required to do so by reasons outside its control or if not practicable to do so, such shorter notice period (including no prior notice) as HKEX-IS may in its absolute discretion determine.
