Further to the Exchange circular (Ref: MO/DT/142/16) issued on 28 Dec 2016, Exchange Participants (EPs) and OAPI Developers are reminded that Volatility Control Mechanism (VCM) in Derivatives Market will be launched on Monday, 16 Jan 2017 barring any unexpected incidents during the optional Connectivity Test on Saturday, 14 Jan 2017. EPs and OAPI Developers are also reminded to ensure that they are well-prepared for the launch and that the appropriate system version (including the appropriate version of their market data system, if any) will be used on the launch date.

After successful completion of the Connectivity Test, the Exchange will confirm the rollout of VCM at 9:30 p.m. or before on the same day (14 Jan 2017) via a special message posted on the HKEX website at the <u>VCM web corner</u>. EPs and OAPI Developers are advised to check the VCM web corner for the implementation status during the weekend.

EPs and OAPI Developers please also be reminded that there will be new session states introduced for the HSI Futures, Mini HSI Futures, HHI Futures and Mini HHI Futures markets due to the launch of VCM in Derivatives Market and both current and new schedules are listed in the below table. For details, please refer to the OAPI Technical Documentations which is also available in the web corner. In case of fallback is required, those new session states will be removed and will not be available in HKATS after fallback.
