Subject: **Reminder on Discontinuation of Displaying Certain Types of Free-Text of Stock**

Reference is made to the Exchange Circular (Ref. No.: [CT/158/21](#)) dated 21 December 2021, Exchange Participants (EPs) are requested to note that with effect from 1 April 2022, certain types of information (“Relevant Information”) currently disseminating through HKEX Orion Market Data Platform – Securities Market (OMD-C) under “FreeText” field of stock (“Free-Text”) will be discontinued, since more comprehensive information are currently available on HKEX websites (<https://www.hkex.com.hk/> or <https://www.hkexnews.hk/>). The discontinuation should have no functional nor interface impact to EPs’ systems. Information Vendors may refer to Market Data Client Notice for corresponding arrangement.

The Relevant Information would be available continuously on the multiple alternative sources on HKEX websites (see the table below). A list of the Relevant Information to be discontinued is summarized in [Attachment 1](#).

This feature is expected to be useful to EPs and market participants that wish to process the information for further usage.

For the avoidance of doubt, the certain information in Free-Text will continue to be provided to market participants is listed in [Attachment 2](#). Market participants are reminded to read the issuer's announcements and circulars in full for complete information.

Information Vendors receives data from OMD-C may or may not be redistributing Free-Text information. EPs are reminded to consult their Information Vendors, if applicable, on any impact of above mentioned changes in OMD-C data.
