**Second Practice Session for Firmware Upgrade of HKEX Backbone Network for Securities Market Systems**

With reference to our Client Notices issued on 8 November 2023 (Our Ref: [MDD/23/667\\_C](#)) and 15 November 2023 (Our Ref: [MDD/23/690\\_C](#)), following the successful completion of the two Practice Sessions, the new firmware version of HKEX backbone network for OMD-C and OMD-CC will be rolled out in production by three phases. To ensure a smooth rollout, three **optional Post Release Tests (PRTs)** will be arranged on **6 January 2024 (Saturday)**, **13 January 2024 (Saturday)** and **20 January 2024 (Saturday)**. **Clients are encouraged to participate in the PRTs to verify the system stability after the backbone network firmware upgrade.**

Direct Connection Clients of Mainland Market Data Hub (“MMDH”) should be noted that MMDH is not in the scope for this upgrade and is therefore not necessary to participate in the PRTs.
