#### Practice Sessions and Post Release Tests for Upgrade of SDNET/2 WAN Gateways

With reference to our Client Notice issued on 18 December 2023 (Our Ref: <u>MDD/23/1677\_C</u>), the upgrade of the Securities and Derivatives Network ("SDNET/2") WAN Gateways as initiated by HKEX's Accredited Vendors ("Upgrade") will take place between mid-February to early March 2024.

Since the Upgrade is technical in nature and confined to the connectivity within the Accredited Vendors' premises, Clients who are using SDNet/2 should note that there will be <u>no functional or</u> <u>end-user connectivity changes</u> due to the Upgrade.

To ensure a smooth upgrade, **two optional Practice Sessions (PSs) and two optional Post Release Tests (PRTs)** will be arranged. Clients who have connectivity to HKEX systems via SDNet/2 are highly recommended to participate in the PSs and PRTs to verify their connectivity readiness to HKEX after the Upgrade.

Subject to the successful completion of the PSs, HKEX plans to upgrade the SDNET/2 Primary WAN Gateways on 2 March 2024 (Saturday) and Secondary WAN Gateways on 9 March 2024 (Saturday). Corresponding PRTs will also be arranged on these Saturdays and registration details of the PRTs will be announced separately after the completion of the PSs.
