## **Market Data Packages for the Mainland Market**

With the aim to provide greater certainty to market data vendors (“vendor”) to plan for their long-term business development and continue supporting Stock connect, HKEX Information Services (China) Limited (“HKEX-IS (China)”) will reposition four Marketing Programmes as permanent packages in the Mainland market (“Mainland Package”) with effect from 1 April 2024.

The Mainland Package is launched based on the following Marketing Programmes relating to Stock Connect and Marketing Programmes on Securities Market Data which are due to expire after 31 March 2024 (Our Ref: [MDD/23/1684 C](#)). The eligibility, requirements, product types, data content and subscriber fees for the Mainland Package remain the same as the marketing programmes with summary below for reference:

Vendors who currently participate in the above marketing programmes do not need to re-submit the application form, they will be automatically entitled to the respective Mainland Package with effect from 1 April 2024. Vendors who intend to apply for the Mainland Package are required to submit the applicable application form(s) for our prior approval.
