With reference to the enclosed Exchange Circular (Ref: <u>EQD/06/24</u>), Hong Kong Futures Exchange Limited (the "Exchange" or "HKFE") plans to introduce the Weekly Hang Seng TECH Index ("Weekly HSTECH") Options contract on <u>2 September 2024</u> ("Launch Date") tentatively, subject to regulatory approval.
