**Arrangement of HKEX Orion Market Data Platform – Securities Market (OMD-C) and Mainland Market Data Hub (MMDH) for Launch of Enhancement of Settlement Arrangement for Multi-counter Eligible Securities**

With reference to our Client Notices issued on 30 May 2024 (Our Ref: [MDD/24/348\\_C](#)), 18 October 2024 (Our Ref: [MDD/24/630\\_C](#)) and 18 December 2024 (Our Ref: [MDD/24/718\\_C](#)) and 24 April 2025 (Our Ref: [MDD/25/165\\_C](#)) regarding the enhancement of settlement arrangement for multi-counter eligible securities in Central Clearing and Settlement System (“CCASS”) by adopting a single tranche multiple counters arrangement (the “Enhancement”), following the successful completion of Market Rehearsal on 24 May 2025, the Enhancement will be launched on **30 June 2025 (Monday)**.

The launch arrangement of the Enhancement is arranged as below:

Before the production launch on 30 June 2025 (Monday), a PRT is scheduled for 28 June 2025 (Saturday). Same as the Market Rehearsal, **all OMD-C and MMDH Data Vendors and ASPs are required** to join the PRT to verify their production systems are ready for the launch. To confirm the participation in the PRT, please complete the [Online Test Participation Form](#) **on or before 13 June 2025 (Friday)**. The test rundown of PRT will be provided to the participating clients by 20 June 2025 (Friday).

Upon the launch of the Enhancement, the information of the relationship between the domain settlement counter (i.e. stock) and other currency settlement counter will be provided in the new message field “DomainStmtSecurityCode” in Security Definition (11) message in both OMD-C and MMDH.

Indirect Connection OMD-C Clients should closely liaise with their feed providing vendors or application service providers for all necessary arrangements to ensure their readiness for the

Enhancement.
