The final strike information of ALA options contracts will be provided by client notice after market close on 11 August 2026 (Tuesday) around 6:30 p.m.

In OMD-D, the information will be available via Reference Data on 11 August 2026 (Tuesday).

Clients and ISVs are requested to review their systems and make adjustments where necessary to ensure that the above stock futures and options contracts information could be handled properly.
